

#### CONTINUED FROM LAST ISSUE

#### FLESHING OUT THE PIPELINE

While in Division reserve security patrols had to be conducted by the 5th RCT." K" Company had an encounter with the enemy and found itself in an intense fire fight. " K " reported casualties of 12 wounded in action (WIA) and 12 missing in action (MIA). several of these MIA found their way and returned to the company. Others may have been mortally wounded and their remains were not recovered at that time.

We are only tracking the Enlisted Reserve replacements in the Fifth RCT with this article. The first casualty reported was in Company "C" February 4, 1951. Pvt. Clarence S. Cota, Jr. was reported KIA. The 5th RCT was engaged in an advance early in February, 1951. There were two Enlisted Reservists from Company "L" were killed February 5th.

Pvt. Arthur L. Hodapp was reported Missing in Action (MIA) March 1, 1951 from Co. "A". It was revealed that Pvt. Hodapp was taken prisoner, suffered and died in captivity. His remains were I.D. and returned to his sister in Freeport, Ill. Our records are in conflict with the story published in the Cincinnati, Ohio clipping published in the 5th RCT newsletter 4th Quarter 2011.

There was a total of about 670 ER replacements received during this period. The first Combat Infantryman Badge (CIB) Awards were noted for February, 1951. The first casualties were listed in February, 1951. With the ER's spread out and the RCT in advance any casualties would be recovered and Med-evaced. There were five other ER's reported KIA in March, 1951.

Heavy fighting continued into April, 1951. On April 4th eight ER's were reported KIA. On the fifth and sixth one ER KIA each day. Eighth Army conducted an attack with several divisions on the 22nd. Before the day ended the Chinese counter attacked with the fighting extending to April 25th. There were no KIA's during this fight because the friendly forces were forced to withdraw and leaving the fallen behind. There were 13 listed as missing. One of these was confirmed as captured and remain a POW till the fighting ended in July, 1953. The 5th RCT was on the right of the line and took a lot of friendly casualties. The 5th was placed in a blocking position behind the 24th Division and were out of action April 24, 1951 with no casualties.

The 24 Division's 19th and 21st Regiments were to withdraw to new positions to the rear of the Fifth RCT, and then the fifth were to withdraw through the division. The 5th's withdrawal was delayed several hours waiting a rescue tank force with the survivors from the 6th Ranger Company. The troops seen headed south were mistaken for ROKA, when they were Chinese infiltrators. This was the beginning of the battle of "Death Valley". Seven ER's from the 1st and 2nd Battalions were listed as Missing in action. This often resulted in being KIA, because the remains were not recovered.

The next action resulting in ER casualties was May 17, 1951 when two from Company "G" were listed as missing. One a squad leader SFC Willard Schipper was severely wounded and thought dead by friend and foe alike, woke after passing out and despite several wounds was able to contact Australian soldiers who came into no-mans-land and carried him to safety. Three more ER's would be killed, 2 in July and one on August 4th from Company "K". The records are not clear as there may have been some enlisted reserves in the Fifth but not in this group. We

canvassed the ER members of the 5th RCT Association asking them how they wound up in the enlisted reserves. Here are their replies.

We had an excellent essay from Willard Schipper that was published in the Newsletter when Arlen Russell was editor in the early 90's.

# 1. Robert Turner of Los Alamos, New Mexico. Bob was in the 36th Division in WWII in Europe. The 36th was a Texas National Guard Division. Bob was a Master Sgt. in the Signal Corps. After the war he thought it was a good idea to join the Army Reserves. Bob was alerted in September 1950 that he would be called up in October 1950 to serve one year. Many of these men were just finishing school, getting married, starting families Etc, many were very angry.

These men were interviewed and if they met certain criteria they may have been excused. Most were not and regardless of their former MOS most were directed to the Far East as Infantry Replacements. The pipeline was like a pipe that had few leaks, and most ended up in Eighth Army rear.

Bob arrived in Pusan Korea early in January 1951 and assigned to the 24th Division and the 5th RCT. He arrived as a M/Sgt and was assigned to S-3 in HQ & HQ Co. 5th RCT. He would remain there till he rotated in October, 1951.

- # 2. John Sonley enlisted in the Army in 1948 for 2 years serving in the Engineers and got separated in 1950, and placed into the Enlisted Reserves. John reported in Chicago with several others and after 3 days on a train arrived at Fort Lewis, Washington State. They all were given an opportunity to plead their case if they were seeking a hardship discharge. Few were successful, they needed replacements in Korea. John was assigned to Co. "M". John provided me with a copy of his rotation orders several years ago and I found it in my files.
- # 3. Richard Zenk may have been with John in that group from Chicago. Richard was a Sgt E-5 and was assigned to HQ & HQ Co S-2 section, and was promoted to M/Sgt. He was separated at Fort Carson, Colo.
- # 4. Grove Smith was an Army medic in 1948when he was assigned to the Enlisted Reserves. He was in Medical school when he got called up. He was assigned to Medical Company in the 5th RCT as a Surgical Tech. He went in October 1950 and separated in October 1951. He sent in a check to help with expenses. He gave up the medical career after being separated.
- # 5. Harry Brunelle ER 46009943 was an E-5 when he was called up in 1950. He was assigned to Co. " A " and was listed as MIA in April, 1951. He was captured and was a POW until his release in 1953. Harry goes to most of our reunions.
- #6. Al Doyle was assigned to "M" Co.. He apparently stayed in the Army and was promoted to E-6, SFC. He was discharged in April 1952.
- # 7. Mike McKillop responded by phone only. He was assigned "B "Co. He was Awarded the CIB in June. This is his story as I recall our telephone conversation.

When his number came up and he was drafted for WWII and his examination judged him 4-F, he couldn't accept that and felt he had to serve. He Joined the Merchant Marine in stead and was trained in New York as an Able Seaman. I'm not clear as to whether he sailed on a

voyage or the war ended and was released. After the war he made an end run on the Army and joined the Enlisted Reserves without a physical. After activation, he needed Basic training, so they sent him to Fort Knox, KY. He took Air borne training, delaying his arrival in Korea. He was assigned to Co. "A" and rotated in October 1951.

- # 8. Bernard J. Wojtasak Pvt. Assigned Co. " F " . My letter to him was returned. apparently he was Deceased in 2010.
- # 9. James Riley was assigned to the motor pool in HQ & HQ Co. When the 5th RCT had a Change of Command on April 20, 1951 Jim was assigned as the driver for Col. Wilson the new Commanding Officer (CO) of the 5th RCT. With the Death Valley Battle about to begin the new C.O. was to be tested. Jim was promoted Cpl E-4 May 30. and Sgt. E-5 Aug. 30,1951 I'm not clear why he didn't rotated on the 18th of October. There was a new change of command in September 1951.
- # 10 & 11 Joseph Meager and Marlin Miller both assigned Co. " C " and both letters returned.
- # 12 Bert Bacon was in 29th Div. in WWII. The 29th went into Normandy June 6th, 1944 He was discharged June 26, 1946. He was talked into joining the reserves by fellow workers. He was recalled in October, 1950 and separated in October 1951 and was discharged.
- # 13 Ralph Yovino was drafted for one year in 1948-49. Recalled in 1950 for one year. He was assigned to " I " Co. He wrote that "I" Company was in heavy fighting in March 1951. Has been seeking a claim without much success with the V.A.
- # 14 Phil Dazley was not one of this group, but was in the 467th Chemical Mortar Battalion and his unit was activated and sent to Camp Atterbury, Ind. to train recruits to become Heavy Mortar men. Phil was promoted to E-4 and E-5 before being shipped to Korea and assigned to Heavy Mortar Company 5th RCT. He rotated in June 1952 and released to the Enlisted Reserve Corps. A little insight of what others were doing during that period.




