





This letter is in reply to the story in the 5th RCT newsletter as to the "flushing out the pipeline", which pertains to the call up of reserves for the Korean War in 1950. This is my story as best as I can remember it in 2014 as to what my government did to me or rather the Congress of the United States did.

I enlisted in 1948 for two years of service, and then would serve in the inactive reserves for about 3 years or so. I was discharged in Feb. of 1950 and transferred into the inactive reserves. That word "inactive" is the key to what Congress did to the inactive reserves.

I was called in September of 1950 to report for active duty in the Army, and to report to Fort Lewis, Washington for duty. Upon reporting, I tried to learn the "why" of an inactive reservist was recalled to serve, but failed to get an answer. While going through the process at Fort Lewis I was amazed at the number of inactive that was there. Some had to closed businesses they had, others had served in WW II and the list goes on. Our questions were never answered until some years later as to what Congress did to the inactive reserves in their haste.

Fast forward to 1960. I was now married, two children and a steady job and while at work, happened to read the Tribune paper and an article pertaining to the call up of inactive reserves in 1950. The mother of an inactive reservist wrote a letter to Congress, demanding to know why her son, who was KIA in Korea, was called up even though he was inactive, not in the active reserves, who are supposed to be the first to be called to duty.

The answer given to her was, Congress had made a mistake and had called the inactive rather than the active reserves. In other words, the

Congress was responsible for the deaths of those inactive reservist who were calliup, due to a mistake. My replacement in October of 1951 was a National Guard member, as were most of the 19 replacements that reported to me for duty, as at the time I was the First Sgt. My replacement was to be a new First Sgt. We shook hands, showed him where the CP was, got on the truck, waved good-bye and the rest is history. I have never forgotten that article as to what Congress did to cause heart ache to many families in 1950.

Those inactive reservist that were KIA in Korea was caused by a mistake made by our Congress.
