

Now to some discussions and decisions from today's meeting.

Next we addressed the prospect of a Florida-wide mini-reunion.

- Holiday Inn Express in Clermont, room \$79.00 +11%. Has same limitations as Tavares HI plus no good restaurant nearby.

A couple of you at today's meeting thought that in view of the somewhat limited turnout today, we perhaps should not rush into the State-wide mini-reunion until we stabilize and build up membership. See what the next quarterly session shows. But when leaving today, a few of you said you would not be at the December 2 luncheon.

We are at a decision point; waiting until Dec 2 to act will really be too late for the Feb date. So, we will cancel out Feb and see where we go on Dec. 2.
